501(c)(3) UPDATE

Lawyers Without Borders has helped us to find legal representation. Orrick, Herrington & Sutcliffe, LLP has agreed to help us finalize the 501(c)(3) application, and the help is definitely welcome. Steve spoke with Perry Israel from the Sacramento branch of Orrick, Herrington & Sutcliffe last week regarding help with the 501(c)(3) application. There are a few more issues to sort out, but we hope to have the application submitted soon. Perry said that we could start soliciting funds before we submit the application which would be tax-deductible, but most donors like to have the application submitted before giving. He also indicated that, if everything goes smoothly, the wait could be as short as four months.
